- Mildred reviewed the reports presented. The Eparchy is moving toward a different financial system in 2020; currently we use an EXCEL spreadsheet that Loran Chrusch implemented. Mildred thanked Loran for his continual support as outgoing treasurer.
- -collection envelopes: the list is directed by the Eparchy; the category called "other" needs clarification
- -Capital Account substantial increase over last year: two donations targeted to this account in the amount of \$20 000. It earns 0.8% interest per annum. Will consider options to grow that money at the Parish Council level.
- -Sunday Offering includes envelopes and Pre-Authorized Debit
- Suggestion made to carol and collect an offering for caroling either in church during the Eve of Theophany service or at the supper.

12. Statement from President:

-Don stated his gratitude for the teamwork of Parish Council. He stated that we aim to be transparent and that everyone has a say in decisions made because we operate with an "open-door policy"— concerns, questions, queries to be directed to Father Andre, Don, Jean, or Jon or an Executive member, which will be addressed in an appropriate and timely manner.

13. New Business:

- a) Signing Officers for 2019 will remain the same as 2018: Mildred Nicol, Fr. Andre Lalach, Don Gabruch
- b) 2019 Operating & Capital Budgets (pages 20 & 21): Mildred reviewed the budgets proposed and described the potential proposed capital projects. Mildred commented:
- -\$20, 000 donations increased the Capital Account significantly
- -the budget is increased to reflect that membership is growing, thus anticipating that donations will match reflect the number of souls in our parish
- -Parish Council Executive agreed on increasing Father's salary by 2% to reflect the CPI (consumer price index)

-page 20: church donations capital reflects the large amount received capital acct targeted donations; projected budget modest in comparison to this past year's donations

-page 21: Transfer to Capital Reserve Acct represents the amount monthly figure transferred from operating to capital and is determined based on donations compared to expenses per month Questions were addressed.

MOTION: Mildred Nicol/Jennifer Clerke to accept the 2019 Proposed Operating and Capital Budgets as presented. Carried.

c) 2019 Annual Eparchial Appeal & Parish Coordinator dates: TBD (April-May). This year marks the 5th year of appeal.

-Father highlighted the funds are directed largely to the work of the Eparchial Catechetical (SSMI), Communications, Family Life, and Youth Ministry offices.

Father Andre asked for a volunteer to be the Appeal Coordinator at the Parish level. Interested members can speak to Fr. Andre if called to this position. In 2018 we received about \$2000 from the Appeal to upgrade WIFI capacity, purchase a new camera, and continue our outreach to people who are unable to be present at Divine Liturgy.

d) Parish Expansion Project

-Jean reviewed the history to date (discussion from 2018 AGM regarding a canopy and new signage) and steps to date; Dormition is the only parish showing growth in the Eparchy

-the task of this project is to illustrate what to do with our property if we decide to move forward -currently the project is in the pre-design phase – what we can do with the current property on this site; verified footprint with zoning bylaws; we had a \$5000 cap to retain the work of professional architects Kindrachuk & Agrey (KA)

Questions for discussion included: the need for a business plan and discussion regarding how we will pay for it; do we have the membership to sustain this growth; what happens if Fr. Andre leaves; what are the risks if we do not move forward; are there other alternatives

-Jean's request: that we complete the pre-design phase to set a reference point what we could do with this property; asking for a motion to finish this first step and move on to creating a committee to formulate a proper business plan with a recommendation to bring to the parishioners to a proper vote

Comments:

- -(page 21 Church Renovations Feasibility Study) Mildred clarified that we have yet to be invoiced for the work of the Architects thus far; we have capped them at \$5000 in work and have not engaged them further
- -an additional approximately \$2500 needed to complete this pre-design phase. Question re: will this give us more information to start making decisions? We will get the precise property survey; the concepts will not change
- -at the Town Hall Meeting in February there was discussion regarding the second level use of space (choir loft additional seating)
- -Council has previously discussed the estimated cost of renovations to be approximately \$100 000 + if the decision was to renovate the basement only; which led to this discussion of a complete renovation
- -a recommendation was made to explore options for renovations (existing basement) would architects be able to give us figures for this and a total renovation project?
- -Questions:
- -what are the priorities? Initially, the pinch points were: welcome area, meeting areas, seating

- -could we do this project in phases? Architects suggested because of the excavation costs involved, better off to do it at same time
- -if we didn't do a total expansion, what could we do? suggestion: relocate mechanical room outside to free up room in basement hall
- -noted that the cost may be more affordable now with society's construction challenges

MOTION: Jennifer Clerke/Mildred Nicol to approve up to \$5000 to finish this first predesign phase (complete renovation) Carried.

Discussion: \$7500 would be the cost of phase I; Bishop only approved \$5000/fiscal year; we capped it at that; seeking to finish the phase may cost up to approximately \$2500 to finish this phase. We are already \$5000 invested from 2018 fiscal year. Parish Council and members as well as the Bishop need to see a Business Plan.

AMENDMENT: Jennifer Clerke/ Mildred Nicol to request information for redesigning the footprint of the existing parameters and floor plan of the church. Carried.

-Note: if you are interested in being on the Committee that will work on a business plan after the pre-design phase is completed, speak to Jean Alonso.

14. Pastor's Summary & Closing Prayer:

- a. outreach some things happen at the hands of the Parish Priest, but most things rely on the work of you...so keep telling the Good News! People will notice the change in you; invite others to join; we are a welcoming community
- b. fellowship opportunities as we grow, there will be folks we have never seen, so introduce yourself and build
- upon relationships; we could consider creating four parish teams of families to complete the tasks of the church
- and to create ways to get to know one another; balance growth with building community. The welcoming area is a
- main priority in the justification of an expansion to enhance fellowship. Kudos to the UCWLC for inviting families to join in baking paskas, perogies, etc. an opportunity to pass on our traditions.
- c. stewardship- request to consider leaving a legacy to our church, not only financially, but through our talents (ex. contributing as a member of the Business Plan Committee)
- -thank you to Bev F. for her work, and welcome to Leanne S. for saying yes to the work as Secretary
- -thank you to Amanda B. for being the Parish Coordinator of the Eparchial Appeal
- -thank you to Cindy Lalach for her work on Fridays in helping to publish the bulletin
- -thank you to all of you for your work; allowing me to step back and not worry about every detail of what is needed; it is a real gift to know there are folks who are willing to take initiative to help out
- -the Divine Liturgy at 5:00 pm is a great opportunity for Liturgy and Worship it has become a growing community

Here are some ways that we have nurtured and engaged our faith both individually and as community this past year, and in the inspiration and realization of Patriarch Sviatoslav's 'Vision 2020' for vibrant parish life:

- Christ Our Pascha Catechism of the Ukrainian Catholic Church inspired 3 all-ages learning events from Fall 2018 to Spring 2019: Part 1 the Faith of the Church, Part 2 the Prayer of the Church, and Part 3 the Life of the Church. Self-study resources also available.
- Royal Doors website www.royaldoors.net provided online Catechism and collection of reflection Qs; plus variety of articles & podcasts i.e. homilies & sermons, divine liturgy, Akathistos & Moleben, iconography, personal prayer, fasting, domestic church, Byzi moms etc
- Dormition Lenten Mission March 20 22 2019 was gifted with the profound sharing of Fr Kevin McGee on the theme of the Human Condition and Mystical Roots, with poignant personal examples inviting us to discovery, healing, and fruitfulness.
- Scripture Study led by Hieromonk Gregory Hrynkiw ASTH brings inspiration and depth. Sessions held weekly on Tuesday evenings 6:30 7:15 pm, hosted by Dormition Parish for the Deanery. Strong attendance weekly, with participants from deanery churches plus guests. Gospel of Matthew focus, from Fall 2018 through Spring 2020.

- Connecting the Liturgy to Our Life with Fr David Petras held Sunday Oct 6th, hosted by Ss Peter & Paul Parish for the Deanery. Recognizing important connections: the depth of God's love, our personal relationship to God, expression in worship and community.
- Preparing for Christ at Christmas, online video meditations offered as we journey to meet Christ, receive Christ; free access, introduction plus series of 4 videos.
- Eparchial Faith Enrichment Program (aka Lay Formation Program) is a 2 yr immersion experience giving time to listen to your heart and to God in a deepening appreciation of Faith and mission; let us pray for current participants Neil Smith and Loran Chrusch.

Adult Catechetical has made possible many faith discovery and faith sharing activities in the life of the parish since 2010.

What follows is a general accounting of tasks performed in 2019:

- stabilized the UCWL flag stand
- changed the fluorescent light in the Women's washroom to a LED fixture
- added and replaced weatherstripping to church exterior doors
- change fluorescent, incandescent and LED bulbs as required
- checked sump pumps often, both water level and operation of pump
- insulated plug openings (to avoid heat loss);
- disposed of ashes from kadylo
- repaired loose and leaking faucets
- repaired caulking as required
- fixed toilets as required
- tightened hinges, latches and knobs on kitchen cupboards
- changed the hot halogen 75-watt bulbs to LED 4.5 watt bulbs in the Women's washroom
- thanks to Loran for edging the lawns and trimming the hedges!
- aligned pews several times a year
- replaced or repaired exhaust fans and vent covers
- cleaned central vac and Roomba
- replaced furnace filters

- checked, repaired and blew out sprinklers
- painted lines in parking lot thanks Roman L. for the help
- checked and replaced door stops;
- maintained cleaning supplies, toilet paper, hand towels thanks to Kimball and Kendra for the help!
- prepared snow shoveling schedule thanks for the help, Fr. Andre. Thanks to all the snow shovelers you are doing a great job!
- sanded and salted icy patches
- responded to all requests and suggestions from parishioners
- set up and took down the Nativity thanks Roman L. for the help
- supervised the replacement of the sewer pipe from the Rectory to the street
- repaired faucet in Rectory

Building Expansion Committee

I would like to thank the committee members Fr. Andre, Don Gabruch, Andrea Bamberger, Chris Fedorowich, Maureen Church, Kimball Lischynski for their time and talent in developing the business plan report, requested of the renovation committee at last year's AGM.

We considered the current state of the church organization, finances, our standing amongst the city parishes and eparchy, and factors that contribute to our vibrancy. A final report was tabled with Parish Council in November 2019. The Committee recommends that prior to embarking on a major capital expenditure, the parish should focus on ensuring the current level of pastoral programming is sustainable regardless of who the parish priest might be, and that the parish should consider establishing a financial council to focus on ensuring the ongoing financial viability of parish, but also with a view of the longer term fund raising necessary to support a renovation or expansion.

How to act on these recommendations was discussed at length with council and evolved into three themes that were reviewed at a special meeting of the parish membership on February 2, 2020. The recommended path forward from this discernment involves:

- i) hiring a program coordinator to support the strengthening of the pastoral programming;
- ii) the establishment of a parish finance committee.

Notwithstanding those key aspects, the constraints that led to the renovation committee being formed in the first place still remain. As such, the membership is also asked if work on the expansion design should continue in 2020.

Hall Usage Report - 2018

Paid functions – 5 events generated revenue of \$500 compared to 9 events for \$1,100 in 2018 and 19 for \$2,625 in 2017. It should be noted that funerals were included in the 2017 amount. They are now allocated to donations.

We also host regular meetings of the Parish Council, UCWL, and Knights of Columbus as well as several eparchial functions at no charge. This represents further use on approximately 60-70 occasions.

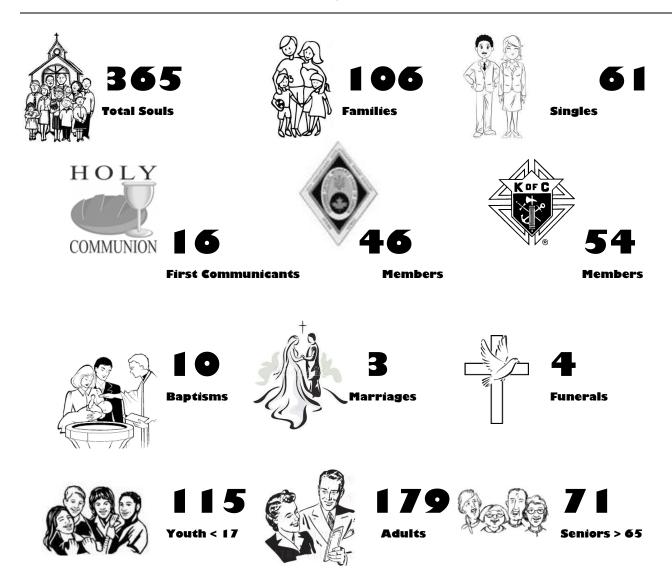
f. Extraordinary Eucharistic Ministry

TREASURER'S REPORT

Through the generous financial commitment by parishioners and visitors to Dormition Parish we continue to maintain a strong financial position and also are able to contribute to our capital reserves in anticipation of final discernment of either renovation or expansion of our church building. In an effort to grow the capital reserve optimally, two GIC's were purchased in May 2019 for higher rate of return compared to a savings account.

Over the past year your donations supported our clergy, the church and rectory, and all utilities, taxes, insurances that maintain our buildings, as well as programming for children's activities and adult participation in faith development. We have also invested in the future of our parish by supporting the architect's survey of potential expansion. Our expenses for maintenance and repair otherwise were modest in the past year including replacement of the hydraulic hoses for the elevator, sump pump repair, and east side church eavestrough repair.

A huge debt of gratitude is owed to Fr. Andre and the 2019 parish council for their continued support of myself in the treasurer position. The work was lightened considerably with the generous assistance of Neil Smith in the record keeping of incoming donations. As always Loran Chrusch gave the gift of his knowledge when I had questions about our database.

The financial report you find in this year's AGM Annual Report was audited once again by Terry Letwin; my gratitude to him as well.

Most importantly thank you to all donors who recognize the financial requirements of our parish community and faithfully provide support through their donations.
